History

- CALAVERAS CONSOLIDATED FIRE PROTECTION DISTRICT (CALCO)
 - Joint Powers Agreement formed in 2012 by merging the Jenny Lind FPD, Foothill FPD to eliminate the duplication of services and reduce costs.
 - The District covers 168 square miles with 4 firefighters and one chief officer out of two fire stations to protect our district.
 - The District serves approximately 1/3 of the population of Calaveras County.
 - On April 5, 2020, the Board of Supervisors approved an ordinance to adopt the 2019 California Fire Code (California Code of Regulations, Title 24, Part 9).



History

- CALAVERAS CONSOLIDATED FIRE PROTECTION DISTRICT (CALCO)
 - On November 8th, 2022, a county wide measure to benefit local fire districts in Calaveras County was defeated with 49.36% supporting the initiative.
 - In 2022, the District established a focus group to determine a Roadmap of Success, pursue additional funding and develop this Strategic Plan to further educate the public on the challenges and opportunities facing the District.




Future State

- The District and its board supports a voter approved initiative to increase funding for the District. This initiative is still pending.
- The Board is committed to creating a financially sustainable fire district to serve the best interests of the public.
- The board is committed to providing a safe and rewarding career path for fire fighters with competitive wages and benefits relative to comparable fire districts.
- Public support and engagement is a key benchmark for our continued success.

Budget Priorities

- Operate within annual budget guidelines and ensure we meet state mandated requirements.
- Competitive salary and benefits structure for full-time firefighters in Calaveras and similar rural counties.
- Seek competitive or alternate options for capital equipment expenditures.
- Be proactive, not reactive.



Budget Considerations

 - Firefighter (strike team) Re-imbursements* (state/federal)
 - State and Federal Grants for equipment and training resources
 - Camanche Fees
 - Exaction/Impact Fees for new construction
 - Equipment sales/facility rental
 - East Bay MUD Fire Fee
 - Hydrant Maintenance for CCWD
 - TOT (Occupancy Tax)
 - Prop 172 Funds



Strengths

- Dedicated innovative professional fire fighters
- Community involvement- fund raisers, outreach and education

Weaknesses

- Reliable sustainable funding
- Staffing turnover and loss of institutional and district knowledge
- Competitive Pay, Benefits and Career Path Opportunities
- Community awareness and education regarding district challenges



Opportunities

- Successful Recruitment and Retention of Firefighters
- Training with other public safety agencies
- Continue development of local training site
- Continue Community Outreach, parades, youth sports leagues, public education in schools, national night out etc.
- Continue high school and college intern program



Threats

- Budget Impact of wage inflation, cost of living etc.
- Public misconceptions (Lack of public knowledge of what we do and who we are)
- Aging fire stations and infrastructure
- Staffing- Challenge to attract and retain firefighters
- Political climate for future tax revenue measures
- Lack of grant opportunities for staffing
- Wildfire threats and limited mitigation
- Insurance-hazard maps and ISO

Strategic Goals

- Secure sustainable sources of funding
- Retain and increase staffing to meet the minimum NFPA Standards
- *Effectively Manage* Operating Costs
- *Enhance* community engagement and support for the District
- Provide a safe and effective work environment
- Support State and Federal Fire Agencies Mutual Aid



Goals and Objectives

- Short term (less than 1 year)
 - Support ballot measures that provide sustainable funding.
 - Provide sustainable career path with industry standard benefits and compensation.
 - Add One (1) Full-time administrative assistant.



Goals and Objectives

- Long Term (1 to 5 years)
 - Staff all three fire stations (Burson, Jenny Lind, Valley Springs)
 - *Ensure* all engines are staffed with three <u>instead of two</u> full time professional fire fighters – per NFPA 1710 standard
 - Actively Support Firewise community organizations
 - *Complete* development of training facility
 - *Improve* water rescue program to support District recreational waterways
 - Add one (1) full-time Battalion Chief

- WE NEED YOUR HELP!
- Calaveras Consolidated is a Special District and is not governed by the County Board of Supervisors, however, beyond property tax there is a limited source of revenue allocations that come from the county.

- Ensure Measure A passes as a roadmap for success. Without Measure A the District will have to make very tough choices which will impact public safety.
